The committee desired for staff to continue looking into the feasibility of a project like this.


4.5 General Updates

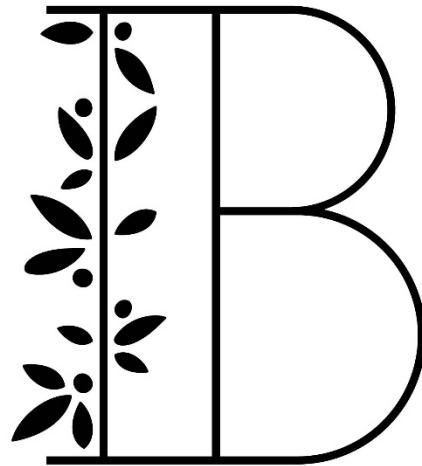
